RIGHT OF CHILDREN TO FREE AND COMPULSORY EDUCATION ACT, 2009.

No.RTE-2019/C.R.25/S.D.-1.— In exercise of the powers conferred by sub-section (1) and (2) of section 38 of the Right of Children to Free and Compulsory Education Act, 2009 (35 of 2009) and of all other powers enabling it in this behalf, the Government of Maharashtra hereby makes the following rules further to amend the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011, as follows, namely:—

- These rules may be called the Maharashtra Right of Children to Free and Compulsory Education (Amendment) Rules, 2024.
- 2. In rule 4 of the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 (hereinafter referred to "as the principal rules"), after sub-rule (5), the following proviso shall be added, namely:—

"Provided that, the Local Authority shall not identify the private un-aided school, for the purposes of 25 per cent. admission of disadvantaged group and weaker section under the Maharashtra Right of Children to Free and Compulsory Education (Manner of admission of Minimum 25% children in Class-I or Pre-school at the entry level for the children belonging to disadvantaged group and weaker section) Rules, 2013, where Government Schools and aided schools are situated within radius of one kilometer of that school."

3. In rule 8 of the principal Rules, in sub-rule (2), the following proviso shall be added, namely:—


"Provided that, no private un-aided school which is identified under the proviso to sub-rule (5) of rule 4 shall be eligible for reimbursement under sub-section (2) of section 12."
